



Participation Waiver

- All participants will be required to wear the safety equipment provided by RockReef and PierZip, where applicable.
- Ensure an instructor has checked your equipment in good working order, where applicable.
- Children under the age of 16 years old must be accompanied by an adult/responsible person over the age of 16 at all times, unless we have the necessary consent form from the child's parent or legal guardian.
- You must listen to the instructions given and follow instructors directions at all times.
- Participants need to be dressed appropriately for the activities - skirts and dresses are not acceptable, unless wearing suitable clothing underneath i.e shorts / thick tights.
- Pockets unless zipped should be emptied and any other loose articles or objects which could become entangled in the safety equipment or fall on a person below must be removed prior to starting the activity.
- Jewellery must be removed prior to starting the activity.
- The consumption of alcohol before or during any activity is strictly forbidden. Anyone found in breach of this rule will be removed from the premises.
- Appropriate footwear must be worn at all time during participation in activities (no open toe shoes or heels or crocs)
- Weight, height and age restrictions apply to some activities and must be adhered to. Restrictions for PierZip activities are also subject to weather conditions e.g. high winds.
- All participants are required to act responsibly and courteously at all times, failure to adhere will not be tolerated.
- You should not attempt to use any piece of equipment or perform a maneuver that you feel is beyond your skill level.
- All activities demand a degree of agility, strength and stamina. If participants are in any doubt about their ability they are advised to speak to a member of the RockReef staff, who will advise you on your suitability.
- You must make our team aware of any medical or physical issues that may limit your enjoyment of any of the RockReef elements.

- RockReef reserves the right to refuse entry to any persons without explanation.
- Use of recording equipment and photography in the RockReef requires permission. CCTV is in operation and footage is the property of RockReef/PierZip solely. Images may be captured for promotional or training material, RockReef reserve the copyright to this material.
- RockReef does not accept responsibility of liability for any loss or damage to any person's property in relation to the usage of RockReef, PierZip and the surrounding areas.
